## 4. Membership and Administration fees:

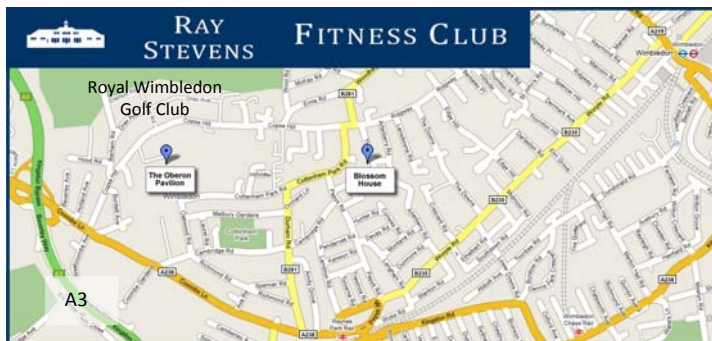

## 6. Terms & Conditions of Membership

**Definitions** - In these Membership Terms and Conditions the following definitions apply: 'the Club' / 'we' means the Ray Stevens Fitness Club; 'the Company', means Ray Stevens Fitness Club Limited. 'Minimum term' means a period of 3 months from the first month of membership.

**Contract** - A contract arises between us once the Contract has been signed and we accept the Contract. This Contract will be governed by the laws of England & Wales.

**Minimum Age** - Membership is limited to persons who are at least 4 years old for Judo, and 7 years old for other activities. You / your child must be at least 16 years of age to participate in weight-based group exercise or resistance training.

**Parental responsibilities** - Parents or adults acting "in loco parentis" must accompany their children before and after all classes. Children must be signed-in upon arrival at each class, to comply with Health & Safety requirements. Children under 14 may not be left unattended on the club's premises and should not be "dropped off" by parents in advance of classes. The Club is responsible only for your child during their class time and when in the dojo/sports hall and not at any other time. Parents not complying with the above may be asked to withdraw their child from further sessions.

**Club Etiquette** - To preserve the safety, comfort, enjoyment and enjoyment of all members, and the Club's reputation, members must comply with the policies for club etiquette set out in the joining pack. Members should wear appropriate kit for their classes (Judo suits for Judo, Karate suits for Karate, etc.). These may be purchased from the Club.

**Misconduct** - We reserve the right to refuse entry to any person, including members, and have the right to cancel your / your child's membership without warning or notice for serious inappropriate behaviour, including but not limited to threatening or harassing, damage to equipment, use of illegal or performance enhancing drugs.

**Payment Of Fees** - All continuous memberships are charged on an annual basis, with 12 equal monthly payments to be paid monthly in advance by Standing Order. Membership fees overdue are subject to interest and additional administration fees for which written notice will be given.

**Administration Fee** - An administration fee is payable for set up and annual renewal of membership. This fee is non refundable, even if you choose to cancel your membership in your Cooling Off period.

**Cooling Off period** - You have a 'Cooling Off' period of 7 days starting on the date a contract is formed. If you wish to cancel your membership in this period, you must notify the Club in writing. We will cancel your contract and refund to you your initial payment less the administration fee.

**Termination/Suspension of Membership** - You may terminate or suspend your membership after the Minimum Term, and upon 30 days notice. Your notice must be in writing and delivered to the address below. We will write to you confirming receipt of your notice and the date of termination or suspension, which will be effective 30 days after the date upon which your termination or suspension notice is received.

**Membership Fee Increase** - We reserve the right at any time, after a minimum term, to increase the fees to be charged, upon reasonable notice.

**Complaints & Feedback** - Ray Stevens Fitness Club welcomes feedback. We will endeavour at all times to assist you with any concerns you / your child may have and would ask you to put any complaints in writing either to the email address below, or by using one of the forms available from the Club.

**Change Of Details** - Please keep us informed of any change of address, email address, contact numbers, bank account & credit card details for payment and any other information relevant to your membership.

**Your Child's Physical Condition** - Members promise and represent on the date of the Contract, and repeat such warranty and representation each time a class is attended, that you / your child are in good physical condition and that you know of no medical or other reason why you / your child are not capable of engaging in active or passive exercise and that such exercise would not be detrimental to your health, safety, comfort or physical condition. Ray Stevens Fitness Club staff and contractors are not medically trained and are therefore only qualified to administer basic first aid. In order that members can engage in active or passive exercise without detriment to their health, safety, comfort or physical condition we strongly advise members take medically qualified advice prior to any exercise program if you are in any doubt about your or your child's ability to engage in active or passive exercise. Members (or the parents or guardians, if under 16) are asked for prior disclosure of any pre-existing condition that may affect their abilities to participate in the Club's activities. Such disclosure is not a legal requirement, but helps the Club and instructors take appropriate precautions to suit the specific needs of the member. Membership will not necessarily be refused to those with even chronic conditions, but the club reserves the right to refuse membership if it is suspected that such a condition exists in the member but has not been disclosed. Members are asked not to attend classes or use any Club facilities whilst suffering from any infections or contagious illness, disease or other ailment or whilst suffering from any physical ailment such as open cuts or sores or minor infections where there is a risk, however small, to other members and guests.

**Claims** - From time to time we may have to close a club premises for refurbishment or because it has been damaged. Under such circumstances classes will move temporarily to an alternative venue/facility. No reduction in membership fees will apply.

**Your Safety And Property** - We hereby give warning that, whilst on our premises you / your child may suffer injuries including broken bones, soft tissue injuries and joint injuries. In consideration of Ray Stevens Fitness Club accepting your application for membership of the Club, and for you becoming and remaining a Member of the Club, you agree that Ray Stevens Fitness Club shall not be liable for any loss, damage or theft of any property belonging to, or brought onto any Club premises by you / your child, occurring on said premises except where caused by gross negligence of Ray Stevens Fitness Club. Also that Ray Stevens Fitness Club shall not be liable for any death, personal injury or illness occurring upon any Club premises or as a result of the use of facilities and / or equipment provided by the Club, except to the extent that such death, personal injury or illness arises from the gross negligence of Ray Stevens Fitness Club.

**Vehicles** - vehicles and their contents, parked in any club car park or elsewhere on the premises of any club are left at the owners risk and we will accept no liability for loss or damage.

**Privacy Statement And Acknowledgement** - The information provided by you on this form and information we may collect about how you use our services will be retained by the Club under the terms of the UK Data Protection Act 1988 and will not be sold or otherwise transferred to any third parties. Occasionally we may take photographs including our club members. These photographs may be used to illustrate our website or in other publications, such as brochures. Information will also be used to: enable us to review, develop and improve our services; administer competitions and other promotional activity; occasionally carry out market research.
